- This award will be presented to an employee without formal technical responsibility for environmental or sustainability management as part of their core duties, they have nonetheless shown an outstanding commitment beyond normal responsibilities to improving the environment and sustainability at their workplace; **OR** a person currently working in an environment and/or sustainability related role who excels beyond expectations.
- The award is only for performance in the previous 12 months, prior to 31 May 2024.
- The nominee must be a Queensland based employee.
- Only one nominee per company for each People's Award category will be accepted.
- Submissions that exceed the stated word limits may be marked down or deemed ineligible.
- You may address the criteria on a separate document (i.e. specially designed PDF) however the completed first page of the relevant nomination form must be submitted for each entry.
- One (1) hi-resolution colour photograph of the nominee that may be used at the event and/or for event marketing purposes \*
